Topic: The Wright Brothers vs. Glenn Curtiss

Speaker: Russ Klingaman

America's first air war was fought in the courtroom, not in the sky.

In 1903 Wilbur and Orville Wright became the first men to ascend in a powered aircraft, the Wright Flyer, at Kitty Hawk, North Carolina. They immediately began to patent their inventions, hoping to capitalize on their work.

They then began to demand that other aviators purchase licenses to allow use of the Wright inventions. Coverage of their patents was so broad that they began to file suit against anyone building a flying machine without paying royalties. This did not sit well with Glenn Curtiss, whose Curtiss Pushers utilized materially different and superior devices such as the aileron to control his aircraft, far superior to the Wrights' wing-warping system.

From 1909 to the beginning of World War I the courts were filled with suits against Curtiss and others. The US Government then stepped in to prevent interference with the war effort.

Join us at the Gallery on November 13th and get the real story behind this complex affair. Our speaker, Russ Klingaman, has excellent credentials for covering the complex legal issues influencing early aviation. Son of a flight instructor and himself a pilot for over thirty years, Russ is an attorney whose practice includes litigating a broad range of aviation related issues. He also teaches aviation law at Marquette University School of Law.
